A2281 - The Smart Container Act - has no real support and the NJ Food Council opposes it.

S771/A2147 - Food Waste bill - Senator Smith will be holding a stakeholders meeting which will include ANJR, Landfill Counties, Rutgers, haulers and businesses that generate large quantities of food waste.

A-2375 - The Electronic Waste Management Act (S-981) was released by the Assembly Appropriations Committee with no changes. It is now on hold awaiting NJDEP amendments.

Carole Tolmachewich reported that the committee held a meeting on April 11<sup>th</sup> in Union County. The will be 3 half-day sessions and the topics presented will be: working together to cleanup your curbside mix; what's in it for you; processors panel; enforcement & education ideas.
